		advisory services - in case of non-performance or undue performance by you of a contract with the Administrator.
7.	Information about the intention to transfer personal data to a third country or international organization	The Company has no intention to transfer your personal data to a third country or international organization.
8.	Period for which personal data will be kept	Personal data provided by you will be stored for 10 years from the date of the conclusion of the Acceleration Agreement in the Project. After the expiry of the periods indicated above, your data will be deleted or anonymized.
9.	Right to request the Administrator to access your personal data	You have the right to obtain confirmation of the fact that your personal data is being processed, as well as to obtain a copy of the personal data being processed.
10.	Right to request the rectification of your personal data	In case your data is incorrect or incomplete, you have the right to request the rectification of your personal data.
11.	Right to request the erasure of your personal data	You have the right to request the erasure of data concerning you, i.e. you have the so-called right to be forgotten, unless the processing of your personal data is necessary for the establishment, exercise or defense of legal claims.
12.	Right to request restriction of processing of your personal data	In the cases indicated in Article 18 RODO, you have the right to request the restriction of the processing of your personal data.
13.	The right to object to the processing of your personal data	You have the right to object to the processing of data concerning you.
14.	Right to the portability of your personal data	You have the right to receive, in a structured commonly used machine-readable format, the data relating to you provided to the Company and to transmit that data to another administrator or to request that the Company transmit that data directly to a designated administrator.
15.	Right to lodge a complaint with a supervisory authority	You have the right to lodge a complaint with a data protection supervisory authority if you consider that the Company's processing of personal data concerning you violates the RODO.

16 .	Right of withdrawal of consent	You may withdraw at any time your consent to the processing of your personal data without affecting the lawfulness of the processing carried out on the basis of your consent before its withdrawal.
17 .	Principle of providing personal data	In order to conclude the Acceleration Agreement with the legal entity for the benefit of which you are the beneficiary in the Project, it is required to provide the data specified in the Acceleration Agreement. Providing data is voluntary, however, their lack results in the inability to conclude and implement the Acceleration Agreement.
18 .	Information on automated decision-making, including profiling	The Company does not make automated decisions or profiling on the basis of the data you have provided.
